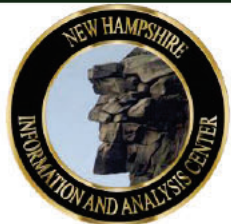

Suspect Qing Wang rented a U-Haul in University City, Missouri, in April 2025. No other Missouri nexus was found.

REQUEST FOR INFORMATION REFERENCE A HOMICIDE INVESTIGATION

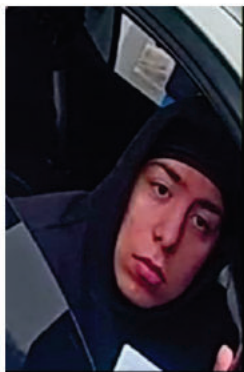
(U//LES) On May 19, 2025 a homicide occurred in Derry, NH. The victim was confronted by four male suspects where he was stabbed and later died from his injuries. It is believed that the homicide occurred during a targeted robbery of a business engaged in shipping/receiving large quantities of iPhones. The suspects drove from NY to NH and utilized a U-Haul van and additional rental vehicles. The U-Haul van transported the suspects at the time of the robbery-homicide, and another vehicle was present in the area conducting surveillance before and during the incident.

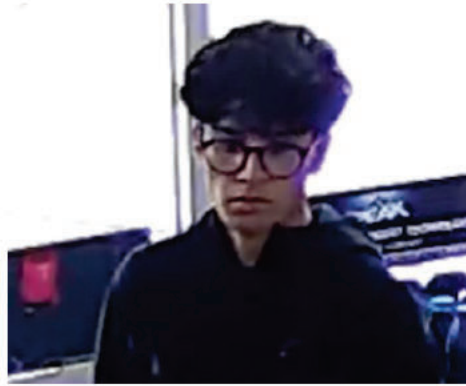
