PUBLIC AWARENESS BULLETIN

The Cole County Sheriff's Office has issued an Endangered SILVER Advisory for a missing adult incident that occurred at 510 Kensington Park, Jefferson City at 8:00 AM on January 7, 2023.

The endangered SILVER advisory missing adult is:

Harland Tyrene Ross, a black, male, age 63, hgt 6' 1", 170 lbs, gray hair, brown eyes, wearing a black jacket, blue jeans, and black shoes. Unique characteristics: has a full gray beard.

Diagnosed Medical Condition(s): Cancer and Dementia

Brief circumstances regarding the Endangered Silver Person incident:

Ross left the Bristol Manor care facility on foot. He was last seen near the Smoke Shop on W Business 50 around 9:00 AM.
